RECYCLING MADE **SIMPLER**

In October 2023, the UK Government introduced the new Simpler Recycling legislation. All businesses and workplaces in England (with ten or more full-time employees) must implement separate food waste and recycling collections by the end of March 2025.

This new legislation aims to clear up confusion over recyclable and non-recyclable materials and standardise recycling practices for homes, workplaces, and schools. This will help to reduce landfill waste and tackle illegal waste activities, promoting a more sustainable and environmentally conscious society.

Under this new scheme, businesses, schools, hospitals and other municipal premises will be required to separate dry recycling, general waste, paper and cardboard and food waste no matter how small the quantity produced.



Waste that must be separated:

REGULATIONS ARE CHANGING

31 MARCH 2025

As of 31 March 2025, businesses, schools and hospitals with **ten or more full-time employees** must follow the new legislation and separate the specified waste streams.

31 MARCH 2027

As of 31 March 2027, businesses, schools and hospitals with **fewer than ten employees** must follow the new legislation and separate the specified waste streams.

What do the new regulations mean for you as the producer?

It is your responsibility as the waste producer to identify if your produce includes any of the affected waste streams and ensure a separate collection service is introduced to comply with the regulation changes.

You may want to take into consideration current practices within your business that generate waste, to highlight any potential changes and help reduce waste production.

Ensuring staff are aware of the incoming changes may also be a factor you need to consider.

You, as the producer, must ensure that your Annual Duty of Care document reflects the separated waste streams, in order to pass any audits and comply with these new regulations.
